**TAX FORMULA:**

**MONTHLY TAX = SALE X MONTHLY FACTOR**

TAX RATES ARE NORMALLY ESTABLISHED IN AUGUST/SEPTEMBER AND STATEMENTS MAILED IN OCTOBER. THE TAX YEAR IS JANUARY 1 THROUGH DECEMBER 31. USUALLY TAXES ARE PAID BY THE LENDER AND THE INDIVIDUAL HOMEOWNER NEEDS ONLY TO BE CONCERNED WITH MAKING HIS MONTHLY PAYMENTS, WHICH INCLUDE PRINCIPAL, INTEREST, TAXES AND INSURANCE.
